

DEED made the 20 nine hundred and thirty-seven WILLIAM ROBERT WILSON of the City of Auckland Company Director of the first part ERNEST HYAN DAVIS of the City of Auckland Company Director (hereinafter called "the Mayor of Auckland") of the second part AND THE AUCKLAND HOSPITAL BOARD a body corporate constituted under "The .. Hospitals and Charitable Institutions Act 1926" (hereinufter called ... "the Board") of the third part WHEREAS the said William Robert Wilson did sometime since place his residence at Takapuna being the lands and premises described in the First and Second Schedules hersto at the disposal of the Mayor of the City of Auckland for the purposes of a Home for Crippled Children in the Province of Auckland .. upon condition that such home should be endowed by a fund to be provided by public subscription AND WHEREAS consequent upon the said offer the Mayor of Auckland invited public subscription to and instituted a campaign for the establishment of a fund by the name of "The Mayor of ... Augkland's Fund for the Endowment of the Wilson Home for Crippled Children" (hereinafter called "the Endowment Fund") and now holds in .. such fund the sum of twenty five thousand eight hundred and forty three bounds. Four shillings and five bence (125,843/4/5)
AND WHEREAS part of the said fund namely the sum of Ten thousand two. hundred pounds was subscribed by Arthur Liston Wilson, Bertha Wilson, Henry Wilson, Frederick Walter Wilson, John Martyn Wilson and Joseph .. Macartney Wilson upon condition that the grounds of the said residence should be maintained in substantially the same condition as they are .. now in AND WHEREAS in the campaign for funds hereinbefore referred to the gentlemen whose names and signatures appear in the appendix hereto were associated with the Mayor of Auckland as his Committee of Businessmen AND WHEREAS there is in the City of Auckland a Society called ty Zealand Cripied Children Society (Auckland Branch) Incorporated having as its object the care of crippled children and the amelioration of their physical social and economic conditions AND WHIREAS the ... Mayor of Auckland having accumulated the endowment fund consulted his . committee of Businessmen and the New Zealand Crippled Children Society (Auckland Branch) Incorporated and with their advice and approval invited The Hospital Board to accept the trusteeship of the said lands and premises and of the endowment fund to the intent that the Hospital Board should establish and maintain upon the said lands a recovery ... hospital where convalescence and post operative cars would be provided

for in ideal conditions for the benefit of crippled children in the province of Auckland as defined by the New Zealand Crippled Children ... Society Incorporated namely "Persons under twenty-one years of age who . not being mentally defective have a defect which causes or tends to -deformity or interference with normal functions of the bones muscles or joints such defective condition being either congenital or acquired but not being a defect of the vital organs X AND WHEREAS pursuant to divers conversations between the parties hereto the said William Robert Wilson with the approval of the Mayor of Auckland and his said Committee of Businessmen has agreed to transfer to the Board the lands described . in the First and Second Schedules hereto TO BE HELD IN TRUST as to ... the lands described in the First Schedule for a Home for convalescent .. crippled children and as to the lands described in the Second Schedule . herete for a site for a Home for non-crippled convalencent children AND WHEREAS the Hospital Board has agreed to accept the said trusteeship upon the terms hereinafter declared and has agreed with the consent of the Minister of Health to establish upon the said lands an "Institute at within the meaning of "The Hospitals and Charitable Institutions Act ... 1926 NOW THIS DEED WITNESSETH that it is hereby agreed and declared as follows: K

- THAT the said William Robert Wilson shall transfer to the Board the lands described in the First and Second Schedules hereto.
 - THAT the Board shall stand possessed of the lands described in . the First Schedule hereto for the establishment of an Institution .. within the meaning of "The Hospitals and Charitable Institutions Act 1926" for the reception relief convalescence and post operative care and treatment and otherwise for the benefit and advancement of orippled children resident within the Auckland Provincial District.
- 5. THE name of the said Institution (hereinafter called "the Home") shall be "THE WILSON HOME FOR CRIPPLED CHILDREN".
- the THE Board shall have power to alter renovate and repair the
 buildings at present on the said land and to erect on the said land
 for the purposes contemplated by these presents any other building .

 or buildings and as and when need may require to demolish alter and
 repair all or any of such buildings.
- 5. \underline{T} \underline{H} \underline{E} Board may in its discretion as and when accommodation in the

Home may be available admit thereto orippled children resident outside the provincial district of Auckland.

- 2) 6. IF at any time there shall be unoccupied beds in the Home which ...
 are not required for crippled children then the Board may while such
 beds are not so required receive into the Home non-crippled convalescent children but no pulmonary-tuberculosis or other infectious
 case shall in any circumstances be received into the Home.
 - 7. THE Board shall in pursuance of the powers vested in it by Statute and subject to any conditions which may be imposed by law in that ... behalf appoint a Committee to have the management of the said Home. subject to the control of the Board. The New Zealand Crippled ... Children Society (Auckland Branch) Incorporated so long as such Society shall be in existence and if the same shall have ceased to ... exist then the Mayor for the time being of the City of Auckland shall be entitled to submit to the Board for its consideration in ... determining the personnel of such Committee the names of three persons who in the opinion of the said Society or the said Mayor are suitable persons to be included as members.
 - 8. THE parties hereto agree that they will use their best endeavours to secure the passing of legislation providing -
 - (a) that the said Home shall be managed by a Committee of Management subject to the control of the Board.
 - (b) that the Committee shall consist of (a) three members appointed by The New Zealand Crippled Children Society (Auckland Branch). Incorporated so long as such Society shall be in existence and . if the said Society shall have ceased to exist then by the Mayor of Auckland for the time being and (b) not more than five members appointed by the Board of whom one shall be the Chairman of the Board who shall ax officio be Chairman of the Committee.
 - (c) that the Home shall be an "Institution" within the meaning of .. the said Act.
 - (d) that notwithstanding anything in the said Act contained the

 powers of the Board in respect of such Institution shall be ...

 limited by thatrusts hereby expressly declared and such trusts .

 shall not cease to apply to the trust premises nor shall the ...

 same be discharged by reason only that the Home shall be constituted an Institution within the meaning of the said Act.

- 9. THE Mayor of Auckland shall pay and transfer the Endowment Fund to the Board to be held by the Board <u>UPON TRUST</u> to use so much ... as shall be necessary of the nett income arising from the investment thereof but not exceeding the income arising from the said sum of .. Ten thousand two hundred pounds for the maintenance and upkeep of .. the grounds of the Home which the Board shall at all times maintain in a condition comparable with the condition thereof at the date of these Presents <u>AND UPON TRUST</u> to use the balance of the income ... arising from the investment thereof for the maintenance of crippled children in the said Home.
